Effective this date, you are authorized to use TSO procedures as prescribed by Subpart O of Federal Aviation Regulations (FAR) part 21 and to identify those parts listed above with the applicable TSO markings as required by their respective TSO. This office must be notified of any design or manufacturing changes to the parts listed above as outlined in FAR §21.611(a), with minor change submittal intervals not to exceed six months.


As a recipient of this authorization, you are required to report any failure, malfunction, or defect relating to this authorization in accordance with the provisions of § 21.3. The report should be communicated initially by telephone to the Supervisor, Technical and Administrative Support Staff, ANM-103L, (562) 627-5300, within 24 hours after it has been determined the failure has occurred and followed up with a written notice. FAA Form 8010-4 (Malfunction or Defect Report) or other appropriate format is acceptable in transmitting the required details.

This authorization is not transferable to another person or location and is effective until surrendered, withdrawn, or otherwise terminated by the Administrator. This authorization pertains only to manufacturing operations at the above address. This office must be notified at least 30 days in advance of any proposed facility relocation to preclude interruption while awaiting quality control approval of that facility. As required by § 21.613(b), you must also notify the Federal Aviation Administration (FAA) when you no longer manufacture a TSO approved article.

Please note that technical data retained by the FAA may be subject to Freedom of Information Act (FOIA) request. As such, this office will notify you of all such request
